# Agenda Item #2

**Approval:** Fiscal Year 2017 Tuition

**Recommended:** That the Board approve the tuition rates for fiscal year 2017, **which are the same as the rates for fiscal year 2016**, to become effective Fall semester 2016. **No tuition increase.**

**Further Recommended:** That the Board approve to decrease eMajor rate from \$250 per credit hour to \$199 per credit hour.

**Further Recommended:** That the Board approve the request of Kennesaw State University to eliminate the premium-priced tuition rate and return to the core graduate tuition rate for the MSN Nurse Practitioner Program, and for in-state students in the MS in Conflict Management and the MA in Global Integrated Communication programs. .

# Mandatory Student Fees

- **Mandatory Fee Criteria**
  - Prior Commitments - Multi-year Fee Plans
  - Increases to Sustain Existing PPVs
- **Staff Review**
  - Business Case/Financial Need
  - Student Approval and Involvement
  - Existence of Significant Fund Balance/Reserves
- **13 Institutions Submitted Mandatory Fee Requests**
  - 22 Fee Requests (*21 increases, 1 new*)
  - 13 Fee Changes Recommended (*12 increases, 1 new,*)
  - Of the 13 Fees Recommended: 6 PPV Related, 3 Multi-Year, 2 Parking/Transportation, 1 Health, 1 Athletic
- Augusta University – Increase SIF by \$30 at Summerville Only. Part of multi-year plan.

# Agenda Item #3

**Approval:** Fiscal Year 2017 Mandatory Fees

**Recommended:** That the Board approve the proposed mandatory student fees for fiscal year 2017 for institutions of the University System of Georgia, to become effective Fall semester 2016.

# Elective Fees and Special Fees Requiring Board Approval

- February 2015, policy changes made to section 7.3.2.2
  - Require Board approval for some fees previously at the discretion of the President
  - Increased review of fees impacting significant populations of students (i.e. all full-time, all undergraduates)
- Recommending the discontinuation of several existing fees at institutions
- Board Policy 7.3.2.2 also requires Board approval for housing fees and food service fees that support debt service on facilities.
  - The recommended increases average ~3%



# Agenda Item #4

**Approval:** Fiscal Year 2017 Elective Fees and Special Charges Requiring Board Approval

**Recommended:** Pursuant to Board Policy 7.3.2.2, that the Board approve the fiscal year 2017 elective fees and special charges being recommended and discontinue fees not being recommended, effective Fall 2016.

**Further Recommended:** Pursuant to Board Policy 7.3.2.2, that the Board approve the housing and food service fee increases that support debt service effective Fall 2016.

# Allocation of State Funds

- Chancellor – Budget Hearings with All Institutions
- \$37.6M provided in new funding for enrollment
- Allocations address 16 institutions with enrollment increases and 14 institutions with enrollment declines
- Strategy/Method:
  - Enrollment gains honored to fullest extent possible
  - Enrollment declines implemented on a case-by-case basis
- Merit Funds Allocated in Proportion to Salary
- M&O Allocated Based on Square Footage
- Other Operating Funds and Capital based on legislative intent

# Agenda Item #5

**Approval:** Fiscal Year 2017 Budget Allocations

**Recommended:** That the Board approve the allocation of state appropriations for FY 2017 among institutions and operating units of the University System of Georgia.

**Recommended:** That the Board approve the FY 2017 Capital Budget totaling \$219,590,000.

All allocations are pending signature of House Bill (HB) 751 by the Governor.

# Salary and Wage Administration

- \$59.5 Million in State Funds for merit-based pay adjustments
- Salary Increases Awarded Based on Merit
- Range 0% to 5% (Exceptions pre-approved by Chancellor)
- Other appropriate fund sources may be utilized to address Market and Compression Issues and Promotions and Reclassifications
